A threat to the nation and a threat to the men: the banning of Depo-Provera in Zimbabwe, 1981 (Amy Kaler) – In 1981, the new government of Zimbabwe banned the use of the injectible contraceptive Depo-Provera. This article tries to explain the particular heat that the Depo-Provera controversy generated in the country. Drawing on archival research in English and Shona, and on retrospective interviews with former family planning workers and middle-aged and elderly Zimbabweans from Wedza and Buhera Districts conducted in 1996, the author demonstrates that the history of fertility regulation in general, and Depo-Provera in particular, led to the construction of Zimbabwean women's reproductive abilities as terrains of struggle between different groups of political interests. Depo-Provera was constructed by Africans as a form of medical colonization of African women's bodies and as a weapon for cutting down the African nation. At the same time, it was associated with 'subversive' conduct by women. The prohibition of Depo-Provera must be seen both as an act of nationalist self-assertion by the newly victorious majority government under ZANU (PF) and also as a significant moment in the gendered politics of reproduction in Zimbabwe.
